Touro College Los Angeles has received a total of \$43,884 from the Department pursuant to the Institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

Touro College Los Angeles has developed a system based on federal guidance, for determining how to allocate these funds, in an equitable and non-discriminatory manner. The method included

distributing the funds to all students who met the Department of Education eligibility criteria to cover expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance, such as food, housing, course materials, technology, health care, and child care). These funds were made available with limited barriers to receipt to students who were:

- enrolled in the Spring 2020 semester;
- in an on-ground degree seeking/certificate program; and
- who filed a Free Application for Federal Student Aid (FAFSA) and met the Department of Education eligibility criteria for Title IV funds.

Only students who are or could be eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, as amended (HEA), may receive Emergency Financial Aid Grants. If a student has filed a FAFSA, then the student has demonstrated eligibility to participate in programs under Section 484 of the HEA.
